#### 1. Call to Order

- iii. Commissioner Dillon was elected unanimously as Secretary.
- A discussion led by Commissioner Walker concluded with an agreement to eliminate the Media Coordinator role and instead strengthen the Secretary's role.
- Motion: Commissioner Mason moved to eliminate the Media Coordinator role, seconded by Commissioner Burns. The motion passed unanimously.
